<u>SCRATCH Tuesday 14th October—Thursday 16th October</u>—Judge Fee and Office Fee retained by VRHA. Show Entry and facility Fee refunded.

<u>SCRATCH Friday 17th October OR AT THE SHOW</u>: No refund granted. Exhibitors that scratch a class for any reason after the draw has been made by the show office will be liable for all fees incurred in connection to entering that class.

Western Show Attire to be worn in both show arena and open pen. Safe and legal equipment is a requirement of entry, no singlets, no caps, no shorts. Wearingof an approved safety helmet is recommended, Mandatory for 13 years & Under. VRHA Show Management reserves the right to refuse entry to any rider not presenting with western show attire and or safe equipment

ARENA USAGE

Arena admittance solely for rider/s and instructors/clinicians/judges. Exception for manure removal and arena setup. Cairnbrook Park Equine & Event Facility require Waiver to be completed and DPI horse movement form to be completed prior riding.

SECURING HORSES

No tying of horses to floats in the main carpark. Horses can be tied to floats in areas allocated and approved by venue owner.

Place horses in undercover yards provided, or secured in your own temporary yards. Horses are not to be left on the property with out the owners present including overnight.

Horses must be walked and led outside of the boundaries of the allocated covered show arena and allocated warm up arena to get to and from the float parking area

riding is only permitted in the warm up and show arena only no lungeing in warm up areas. Please contact show management for usage of the safe lungeing area.
